(a) A person commits an offense if he recklessly hinders an offense if he intentionally hinders an official proceeding by noise or violent or tumultuous behavior or disturbance and continues after explicit official request to desist, and, (c) An offense under Section 38.15, Texas Penal Code is a Class A misdemeanor.
